AltaSigna is an electronic document delivery solution which enables bulk creation, encryption, digital signing and dispatching of electronic documents.

8) How does AltaSigna Work?

AltaSigna helps you manage the complete lifecycle of documents from creation to delivery. The product has three distinct components that accomplish the task.

Document Generator – Preprocessing

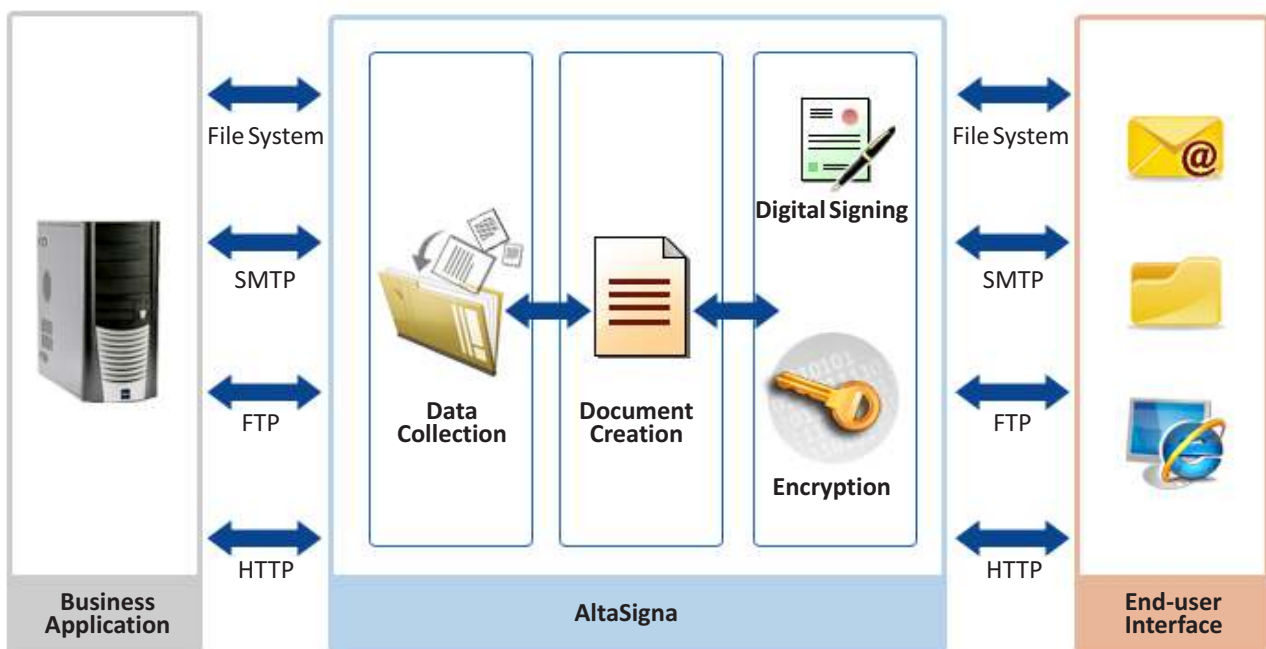
- AltaSigna collects the source file from the configured data source of the business application, at a pre-defined intervals
- Source data can be any file format that uses only ASCII characters HTML,XML,PRN,CSV,PDF,TEXT
- The document is parsed by the application using source parsing templates
- Documents are rendered into PDF/HTML layout through rendering templates
- PDF documents are encrypted using ARC4 algorithm

Document Signer – Signing

- Documents are signed with the configured private key in the application
- This component supports both parallel and cover signatures

Document Distributor – Dispatching

- The signed document is distributed to the intended recipients according to the preferred mode of distribution viz., File System, Mail System, FTP, HTTP
